D. , Dickinson School of Law, Carlisle, Pa. , 1988. Lawyer, private practice. Bucks County, Pa. Commissioner, 1995-2004. Elected as a Republican to the One Hundred Ninth Congress (January 3, 2005-January 3, 2007). Unsuccessful candidate for reelection to the One Hundred Tenth Congress in 2006. Elected as a Republican to the One Hundred Twelfth and to the two succeeding Congresses (January 3, 2011-January 3, 2017). Was not a candidate for reelection to the One Hundred Fifteenth Congress in 2016. Died on January 6, 2020. Interment at Washington Crossing National Cemetery, Upper Makefield Township, Pa.
