A Representative from Arizona. Born in Rock Springs, Sweetwater County, Wyo. , November 27, 1958. Graduated from Pinedale High School, Pinedale, Wyo. , 1977. B. S. , Creighton University, Omaha, Nebr. , 1981. D. D. S. , Creighton University, Omaha, Nebr. , 1985. Dentist. Elected as a Republican to the One Hundred Twelfth and to the seven succeeding Congresses (January 3, 2011-present). Censured by the U. S. House of Representatives on November 17, 2021, for having "posted a manipulated video on his social media accounts depicting himself killing Representative Alexandria Ocasio-Cortez and attacking President Joseph Biden. "
