S. , Florida State University, Tallahassee, Fla. , 2003. J. D. , William & Mary Law School, Williamsburg, VA, 2007. Lawyer, private practice. Member of the Florida state house of representatives, 2010-2016. Elected as a Republican to the One Hundred Fifteenth and to the three succeeding Congresses until his resignation on November 13, 2024 (January 3, 2017-November 13, 2024). Reelected to the One Hundred Nineteenth Congress, but declined his seat.
