Cattle rancher. Businessman. Member, East Nicolaus High School Board of Trustees, Nicolaus, Calif. , 1977-1980. Member of the California state assembly, 1980-1986. Elected as a Republican to the One Hundredth and to the twelve succeeding Congresses (January 3, 1987-January 3, 2013). Was not a candidate for reelection to the One Hundred Thirteenth Congress in 2012.
