Co-founder and managing director, private equity investment firm. Commissioner of the Tennessee Department of Economic and Community Development 2011-2014. U. S. Ambassador to Japan 2017-2019. Elected as a Republican to the United States Senate in 2020 for the term ending January 3, 2027.
