A. , Northeastern State University, Tahlequah, Okla. , 1992. Real estate broker. Member of the Oklahoma state house of representatives, 1995-2002. Elected as a Republican to the One Hundred Seventh Congress, by special election (January 8, 2002) in anticipation of the vacancy caused by the resignation of United States Representative Steve Largent, and reelected to the five succeeding Congresses (February 15, 2002-January 3, 2013). Unsuccessful candidate for nomination to the One Hundred Thirteenth Congress in 2012.
