Elected as a Republican to the One Hundredth and to the seventeen succeeding Congresses (January 3, 1987-January 3, 2023). Chair, Committee on Energy and Commerce (One Hundred Twelfth through One Hundred Fourteenth Congresses). Was not a candidate for reelection to the One Hundred Eighteenth Congress in 2022.
